) **AMENDED ORDER ¹**

This matter comes before the court pursuant to the Commission on Lawyer Regulation’s (“Commission”) recommendation of individuals for appointment to the Investigative Committee and Hearing Panel under Rule 2(d)(3) of the comprehensive regulatory system of the Guam Rules of Lawyer Disciplinary Enforcement and Disability Proceedings (“Rules”). *See* Supreme Court Case No. PRM21-001. The recommendations for the Investigative Committee (Rule 3) and the Hearing Panel (Rule 4), both of which shall consist of five lawyer members and two public members, were sent by letter to the Chief Justice of the Supreme Court of Guam on July 1, 2021, July 14, 2021, and August 27, 2021.

In consideration of the foregoing, and in furtherance of the court’s plenary authority to govern attorney and judicial ethics in Guam pursuant to 48 U.S.C.A. § 1424-1(a)(7), the court
